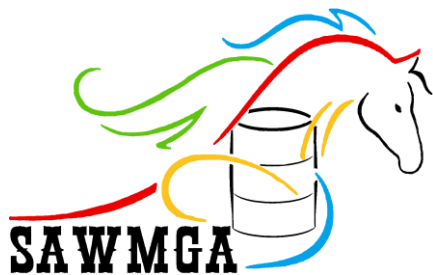

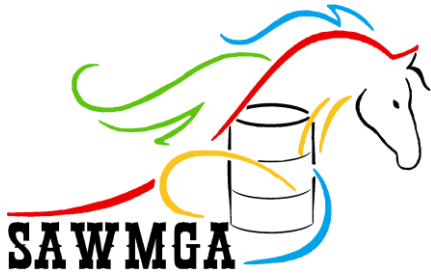

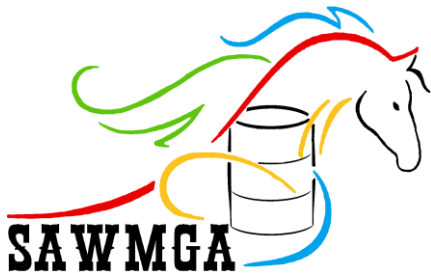
Terms and conditions document

I, _____, am duly authorised to sign the terms and conditions of **SAWMGA** on behalf of _____ club, which held a meeting on _____ and resolved to form a club/affiliate an existing club its existing membership of the District, in order to facilitate competitive and recreational equestrian activity for its participant base. I hereby confirm that all information contained in our application for membership, or renewal thereof, is true and correct, and that the club will be bound by the Terms and Conditions of Membership as set out below:

- The member(s) representing SAWMGA on the Club's council must be fully affiliated to SAWMGA and the SAEF, either as full participant Members, Non Rider Members or as Administrative Members
- We have 5 or more bona fide individuals who will join SAWMGA as **participant Members**.
- The club committee guarantees payment of all amounts owing by the club to SAWMGA
- Should any outstanding amounts not be paid within 7 days after final written demand of such payment, the club will be placed in bad standing and all benefits to it and its participants will cease
- Should the outstanding amounts still not be paid within 30 days of final written demand, the club will be deregistered from the SAWMGA structures and future applications may be rejected.

- The club undertakes to provide all details to the SAWMGA, as any person who applies to become a Member of SAWMGA have to be a SAWMGA Club Member in good standing before his/her application can be accepted.
 - The Club agrees to be bound by the rules and regulations of the SAWMGA as published on the website from time to time
 - The Club constitution will be in line with that of SAWMGA as far as possible, and where there is a conflict, the constitution of the SAWMGA shall apply.
 - The Club undertakes to have its books presented in annual financial statements, which are either audited or independently reviewed.
 - The club agrees to dutifully distribute all correspondence received from the SAWMGA to its members in a timeous and effective manner.
 - The club indemnifies SAWMGA and its parent District, Provincial and National Bodies and its office bearers against all damages, losses, charges, costs, and all other expenses and liability that may be incurred by any member, office bearer or competitor due to an accident or any other incident that may occur during any equestrian or other activities that the club is involved in
 - The Club will at all times ensure that proper and comprehensive insurance (provided through SAWMGA, the SAEF or its own means) is in place to cover all liabilities that may result from activities of the club
 - The Club will ensure that it has the necessary events permits in place when running events through its Show Holding Body (SHB), or whether it runs events itself. It will ensure adherence to all safety regulations and legislation as is required for the running of Sports Events.
 - The club will ensure that, when using another SHB than itself, that the SHB and the Club has Service Level Agreements in place with the relevant Disciplines that will be covered by the events that the Club is planning to host
 - The club agrees to send updated information to the SAWMGA should any of its details change, as soon as the change takes place
 - SAWMGA guarantees that all information regarding the club, its members and all its documents will be treated as strictly confidential and that only persons duly authorised to do so, will have access to the aforementioned details.
 - The Club agrees to do its utmost best to promote/progress the Sport of Western Mounted Games in its District and to ensure that the welfare of the athletes and horses will be of paramount importance.
 - The Club agrees to promote and support Western Mounted Games in the SANESA (Schools) Program.
 - The Club agrees to keep the integrity of the spirit of Western Mounted Games to the highest possible standard.
 - The Club agrees to keep the level of knowledge of its Instructors and Judges to the highest possible level by attending Clinics and Workshops.

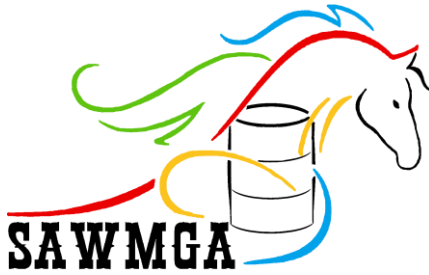

ANNEXURE B SAWMGA REGULATIONS

7.1 Requirements To Become WMG Club

Any individual that is a current SAWMGA member, and who wants to start a new club can apply to SAWMGA through the Members Club and host SAWMGA shows if they meet the following minimal requirements.

The new club must:

1. Be willing to host training shows and assist with district and provincial qualifiers.
2. Have enough riders and workers who are willing to participate in the local area. It is necessary to have a petition signed by:
 - a. Five (5) riders who are members or who will sign up as SAWMGA members and attend shows,
 - b. Five (5) people to work at a show as secretaries, announcers, gate persons, etc.,
3. Have access to an arena that is safe and large enough to run events for a training show.
4. Have access to at least one SAWMGA Accredited Senior Judge.
5. Pay an annual affiliate-Membership fee as determined by the Board of Directors at the AGM.
6. Have their own bank account
7. Have a club committee consisting of at least a President, Vice-President, Secretary and Treasurer elected at an official inaugural meeting.
8. Have a signed Club constitution.
9. Club Affiliates are expected to support SAWMGA as follows:
 - a. Support regional and national shows and assist where necessary with accredited judges.
 - b. Provide loan of equipment and timers as may be required
 - c. Uphold SAWMGA rules and regulations.

If you can meet the above requirements, you should have no difficulty forming a WMG Club and presenting SAWMGA sanctioned shows.
